GUIDELINES FOR MOP-UP ROUND COUNSELLING FOR THE ACADEMIC SESSION 2025-26

(For ANM / Basic B.Sc. / Post Basic B.Sc. / M.Sc. / Post Basic Diploma Nursing Courses)

- 1. It has been observed that after completion of all regular and special rounds of counselling, a few seats in Government Nursing Institutions (ANM / Basic B.Sc. / Post Basic B.Sc. / M.Sc. / Post Basic Diploma Nursing Courses) remained vacant. To fill up these vacancies, it is decided to conduct a Mop-Up Round Counselling for the academic session 2025–26. This shall be the final phase of the counselling process. Any seat remaining vacant thereafter shall remain unfilled.
- 2. The Mop-Up Round shall be conducted **only for Government Nursing Institutions** to fill up the remaining vacant seats.
- 3. **Only State Quota merit-listed candidates** shall be eligible to participate in this round.
- 4. Eligible State Quota merit listed candidates are required to log in using their *Application Number* and *Password* and fill and lock their fresh choices of institutions on the official website: dohodisha.nic.in within the prescribed schedule given below.
- 5. All vacant seats in Government Institutions shall be treated as **Unreserved (UR)** for the Mop-Up Round. No category-based reservation shall be applicable in this phase.
- 6. Admission shall be made **strictly on the basis of State Quota Merit Rank**.
- 7. Once a candidate is allotted a seat in the Mop-Up Round, he/she must take admission in the newly allotted institution, and any previous admission shall **automatically stand cancelled**.
- 8. Admission in the Mop-Up Round shall be **treated as final**, and **no further change of seat** will be permitted.
- 9. The seat vacated by a candidate previously admitted elsewhere shall be immediately filled up by the next eligible candidate in the merit list.
- 10. Candidates are advised to visit the official website regularly for updates. Failure to complete the online choice filling and locking process within the stipulated time shall result in **no allotment**.
- 11. The decision of the State Nursing Selection Committee shall be **final and binding** in all matters relating to the Mop-Up Round Counselling.
