- financial assistance to SC/ST students irrespective of KBK & Non-KBK districts towards the expense of books, internet service and study material @ Rs.24,000/- per annum.
- Sponsored SC/ST students have to execute a bond with Government which will be provided during admission subject to provision of funds by the appropriate authority.

For Basic B.Sc. course

SC / ST candidates for admission into B.Sc. Nursing Course in ONMRC recognized Private Institutions, financial assistance will be borne by NHM, under "Swasthya Sebika Nijukti Yojana" (SSNY) Scholarship Scheme as follows:

Subject to approval of competent authority /funding agency as under: -

- financial assistance to SC/ST students irrespective of KBK & Non-KBK districts towards the expense of books, internet service and study material @ Rs.24,000/- per annum.
- Sponsored SC/ST students have to execute a bond with Government which will be provided during admission subject to provision of funds by the appropriate authority.

Sub: Discontinuation of Financial assistance to ST/SC girl students from NHM under "Swastya Sevika Nijukti Yojana"

Madam/Sir,

With reference to the subject cited above, this is to inform you that, the financial assistance given to ST&SC girl students those are pursuing GNM/B.Sc nursing courses in Pvt. Institutions under Swastya Sevika Nijukti Yojana (SSNY) shall not be continued further from the admission batch of 2023-24, considering the excess number of Nursing institutions in the State.

Further, as per the Post- Matric Scholarships issued by Ministry of Tribal Affairs, GoI., the students belonging to Scheduled Tribe & Scheduled Castes for studies inside India, it is mentioned that a scholarship holder under this scheme should not hold any other scholarship/ stipend. If awarded with any other scholarship/ stipend, she can opt for whichever is more beneficial to her.

Keeping in view of the above, the financial assistance given to ST&SC girl students pursuing GNM/B.Sc Nursing under "SSNY" shall be closed from the admission batches 2022-23. However, the District will ensure the pending dues till the admission batch 2022-23.
